Know ye that I the said Jacob Blount in consideration of the love & natural affection I have and do bear to Cousin Mary Blount, daughter of Benjamin Blount and his wife Phenelephas, and to my cousin Jacob Sutton, son of Solomon Sutton and Mary, his wife, and to Isaac Hardee Coward, son of Needom Coward and Phebe, his wife, and to Isaac Turnage, son of Selah Turnage, and for divers good causes moving me thre to have given, granted, and by these presents do give, grant and confirm unto my near relations and friend above name, To my cousin Mary Blount one negro girl named Fan, about eight years old, to my cousin Jacob Sutton, above said, one negro girl named Hannah to Hardee Coward one negro girl named Seuina together with the increase of the above negroes by breeding, and to my friend Isaac Turnage all the rest of my whole estate both royal and personal that shall remain after the decease of my self and wife if the said Isaac Turnage should live to the age of twenty-one. But in case the said Isaac Turnage should depart this life before he arrives to that age, then my estate that is given to him on that condition to return to my lawful heirs; to have and to hold the above named slaves, above said specifically given to Isaac Turnage there...and assigns forever provided nevertheless and be it understood that the above negro slaves are given granted on this consideration and the true intention of the donor is that the above given slaves shall be and remain with the donor his one proper care until his death and his wife, and then to be delivered to the above named persons specifically given but the profit of the slaves that may arise from their labor shall belong and accrue to their donor, with condition nevertheless that the said slaves be supported and maintained, also that the remaining part of my estate that is before given to my friend Isaac Turnage be delivered to him according to the true intent of the above gift.
